## The Consumer Protection (Trade Fair and Exhibition) Regulations 2003

#### GN 50/2003

#### THE CONSUMER PROTECTION (PRICE AND SUPPLIES CONTROL) ACT

# Regulations made by the Minister under section 35 of the Consumer Protection (Price and Supplies Control) Act

- 1. These regulations may be cited as the **Consumer Protection (Trade Fair and Exhibition) Regulations 2003**.
- 2. In these regulations-

"applicant" means a person, company or association applying for authorisation to hold a trade fair or exhibition;

"exhibition" -

- (a) means a commercial event of a period of not less than one day, nor more than I 0 days, at a specific place where participants are allowed to exhibit their products and services;
- (b) does not include an event organised for one day for fund-raising purposes by an educational, a governmental or a non-governmental organisation;

"organiser" means an applicant who has obtained authorisation to hold a trade fair or an exhibition under these regulations;

"participant" means a Mauritian or foreign person to whom, or a Mauritian or foreign company or association to which, a stand in the trade fair or exhibition is, or is to be, allocated by the applicant or organiser, as the case may be;

"rental", in relation to a rented building or premises -

- (a) means the amount paid as rent for the use of the building of premises for the holding of a trade or exhibition;
- (b) includes any amount paid to the owner or lessor of the building or premises, or to any other person, for electricity or water services in connection with the use of the building or premises for the holding of a trade fair or exhibition;

"trade fair" -

(a) means a commercial event of a period of not less than one day, nor more than 10 days, at a

specific place where participants are allowed both to exhibit and to sell their products and services;

(b) does not include an event organised for one day for fund-raising purposes by an educational, a governmental or a non-governmental organisation;

3. (1) Any person wishing to hold a trade fair or an exhibition shall apply to the Minister for authorisation in the form set out in the First Schedule, not less than one month before the proposed first day of the trade fair or exhibition.

- (2) No authorization shall be given for the holding of a trade fair or exhibition -
  - (a) on 12 March;
  - (b) on 1 May; and
  - (c) at any time during the month of December
- (3) No person shall hold a trade fair or exhibition suggestive of a form of patronage from a state, an international organization or a national organization, unless he has obtained a written authorization from that state or organization.
- (4) No person shall be authorised to hold a trade fair or an exhibition more than once monthly.

- 4. (1) No trade fair or exhibition shall be held unless the Minister has given his written authorisation upon an application made under regulation 3.
  - (2) No authorisation shall be given for the holding of a trade fair or exhibition at any time during the month of December.
  - 5. (1) The Minister may grant an application, subject to-
    - (a) payment by the applicant to the Accountant General -
      - (i) where the applicant is the sole participant, of a fee of 25,000 rupees;
      - (ii) where there is more than one participant and-
      - (iii) where the trade fair or exhibition is to be held for a period of one day or 2 days, of a fee of 10,000 rupees;

# SECOND SCHEDULE

(regulation 5)

#### **CONDITIONS**

- Every organiser and participant shall comply strictly with the laws relating to consumer protection and the Fair Trading Act.
  - 2. The area of each stand shall not be less than 9 square metres, and walking space of not less than 2 metres shall be provided for the public between any 2 rows of stands.
- 3. Every stand shall be occupied by not more than one participant and shall, in no circumstances, be sublet to any person, company or association other than the participant named in the application form.

- 4. The organiser shall provide a desk on the premises where the trade fair or exhibition is held, for the Consumer Protection Unit of the Ministry responsible for the subject of consumer protection to receive and attend to any public enquiry or complaint.
  - 5. The organiser shall provide an identification badge to each participant, a sample of which shall be submitted to the Ministry responsible for the subject of commerce, not less than 2 weeks before the proposed first day of the trade fair or exhibition.
