

Consumer Protection (Control of Price of Fertilizers) Regulations 1998

GN 177/1998

THE CONSUMER PROTECTION (PRICE AND SUPPLIES CONTROL) ACT 1998

Regulations made by the Minister under section 3 and 35 of the Consumer Protection
(Price and Supplies Control) Act 1998

1. These regulations may be cited as the Consumer Protection (Control of Price of Fertilizers) Regulations 1998.
2. The maximum prices at which fertilizers may be sold shall be as laid down in the Schedule.
3. The Fertilizer (Maximum Price) Regulations 1991 are revoked.
4. These regulations shall be deemed to have come into operation on 5 October 1998.

Made by the Minister on 10 November 1998.
